1 I, Helen Tellyer, declare:

2 1. I have personal knowledge of the facts set forth in this declaration and, if called as  
3 a witness, I could and would testify competently to these facts under oath.

4 2. I was born on March 7, 1935 and am 77 years old and I live at 3810 Five Mile  
5 Drive, Stockton, California.

6 3. I was hired by the City of Stockton in November of 1979 and retired in August of  
7 2001 as a Telecommunications Supervisor.

8 4. I have no dependents on the City's Health Plan and I am eligible for Medicare.

9 5. My PERS retirement check is \$2614.22, and my annual household income is  
10 \$46,960.00.

11 6. I am informed and believe the City has adopted a monthly premium for retiree  
12 health benefits. If required to pay this premium to receive City Health Plan benefits, even with a  
13 \$300 subsidy that has been offered by the City for one year, my premium would be \$128.63  
14 monthly and \$1543.56 annually. It would be a hardship for me to pay the 20% difference in

1 what Medicare pays and what my secondary insurance with the City of Stockton pays if I were to  
2 lose my medical insurance with the City.

3 7. I have osteoarthritis for which I take pain medication twice daily. I also take  
4 medication for cholesterol and high blood pressure, neither of which are yet in generic form,  
5 making them more expensive.

6 8. I declare under penalty of perjury under the law of the United States of America  
7 that the foregoing is true and correct and that this declaration was executed in Stockton,  
8 California, on June 29, 2012.
