IT IS FURTHER ORDERED that a conference will be held on August 30, 2012, at 10:00 a.m. in Courtroom No. 35, 501 I Street, Sacramento, California, to be conducted by the judicial mediator for the purpose of discussing and organizing the judicial mediation.

IT IS FURTHER ORDERED that, not less than three (3) business days before the scheduled conference, counsel for the City of Stockton shall provide to the judicial mediator via facsimile to 503-326-1502 or electronic mail to the judicial mediator's law clerk, bethany\_coleman-fire@orb.uscourts.gov, but not file, a

list of matters that may benefit from mediation and shall identify the pertinent parties and their counsel, if any.

Counsel shall deliver a copy to all parties identified, who may, no later than noon the business day prior to the scheduled conference, provide to the judicial mediator via facsimile or electronic mail, but not file, and deliver to the City of Stockton's counsel a written response, including any suggested alternative suggested list of matters that may benefit from mediation.

This order is without prejudice to the employment by the parties of any private mediator with whom they may also wish to work.
