ON NOVEMBER 8, 2013, AROUND 11:47 P.M., THERE WAS A TRIPLE HOMICIDE THAT OCCURRED AT A RESIDENCE IN THE 300 BLOCK OF S. LAUREL STREET. FIVE PEOPLE WERE SHOT. THREE OF THEM WERE SHOT TO DEATH.

THE VICTIMS ARE EMMANUEL RUIZ, 27, FIDEL PEREZ CORDOVA, 50, AND OLIVIA RUIZ, 56.

THE SUSPECTS ARE DESCRIBED AS FOLLOWS:

- TWO HISPANIC MALES IN THE 30'S, ONE SHORT, ONE TALL. THEY FLED IN A BLACK TRUCK WHICH WAS PARKED ACROSS THE STREET FROM THE HOMICIDE LOCATION.
