No. 564, should be modified such that (i) any references to "November 9, 2012" are hereby deleted and replaced by "December 14, 2012"; and (ii) any references to "December 21, 2012," are hereby deleted and replaced by "February 8, 2013."





IT IS HEREBY ORDERED that:

No. 564, is modified such that (i) any references to "November 9, 2012" are hereby deleted and replaced by "December 14, 2012"; and (ii) any references to "December 21, 2012," are hereby deleted and replaced by "February 8, 2013."
