2 in the case styled *In re City of Stockton, California*, Case No. 2012-32118, currently pending in
3 the United States Bankruptcy Court for the Eastern District of California, hereby proposes the
4 following First Amended Plan of Adjustment of Debts for City of Stockton, California, As
5 Modified (~~June 2,~~August 8, 2014), pursuant to section 941 of the Bankruptcy Code.¹

6 Please refer to the Disclosure Statement for a discussion of the City’s financial
7 condition, the developments throughout the Chapter 9 Case, and for other important information.
8 The City encourages you to read this Plan and the Disclosure Statement in their entirety before
9 voting to accept or reject this Plan. No materials other than the Disclosure Statement and the
10 various exhibits and schedules attached to or incorporated therein have been approved for use in
11 soliciting acceptance or rejection of this Plan.

12 **I. DEFINITIONS, INTERPRETATION AND RULES OF CONSTRUCTION**

13 **A. Definitions.**

14 **1. 2003 Fire/Police/Library Certificates** means the 2003A
15 Fire/Police/Library Certificates and the 2003B Fire/Police/Library Certificates.

16 **2. 2003 Fire/Police/Library Certificates Reimbursement Agreement**
17 means that certain Reimbursement Agreement, dated as of June 1, 2003, by and between the
18 Successor Agency and the City.

19 **3. 2003 Fire/Police/Library Certificates Supplemental Trust Agreement**
20 means the First Supplemental Trust Agreement, dated as of May 9, 2013, by and among Wells
21 Fargo, the Financing Authority, and the City, the form of which is attached as Exhibit B to the
22 Declaration of Robert Deis in Support of the City of Stockton’s Motion Under Bankruptcy Rule
23 9019 for Approval of Its Settlement with Ambac Assurance Corporation, filed in the Chapter 9
24 Case on February 26, 2013 [Dkt. No. 725].

4. **2003 Fire/Police/Library Certificates Trust Agreement** means the Trust Agreement, dated as of June 1, 2003, by and among Wells Fargo, the Financing Authority, and the City, relating to the 2003 Fire/Police/Library Certificates.

5. **2003 Fire/Police/Library Certificates Trustee** means Wells Fargo, as trustee under the 2003 Fire/Police/Library Certificates Trust Agreement, or any successor trustee thereunder.

6. **2003A Fire/Police/Library Certificates** means the Certificates of Participation (Redevelopment Housing Projects) Series 2003A, issued on June 27, 2003, in the original principal amount of \$1,160,000.

7. **2003B Fire/Police/Library Certificates** means the Certificates of Participation (Redevelopment Housing Projects) Taxable Series 2003B, issued on June 27, 2003, in the original principal amount of \$12,140,000.

8. **2004 Arena Bond Indenture** means the Indenture of Trust, dated as of March 1, 2004, by and between the Successor Agency and the 2004 Arena Bond Trustee, relating to the 2004 Arena Bonds.

9. **2004 Arena Bond Insurance Policy** means the Municipal Bond New Issue Insurance Policy No. 04010198 issued by NPMG, as successor to Financial Guaranty Insurance Company, with respect to the 2004 Arena Bonds.

10. **2004 Arena Bond Trustee** means Wells Fargo, as indenture trustee under the 2004 Arena Bonds Indenture, or any successor indenture trustee thereunder.

11. **2004 Arena Bonds** means the Successor Agency of the City of Stockton Revenue Bonds, Series 2004, (Stockton Events Center – Arena Project), issued on March 26, 2004 in the original aggregate principal amount of \$47,000,000.

12. **2004 Parking Bond Indenture** means the Indenture of Trust, dated as of June 1, 2004, by and between the Financing Authority and the 2004 Parking Bond Trustee, relating to the 2004 Parking Bonds.

1 **13. 2004 Parking Bond Insurance Policy** means the Municipal Bond New
2 Issue Insurance Policy No. 04010390 issued by NPF, as successor to Financial Guaranty
3 Insurance Company, with respect to the 2004 Parking Bonds.

4 **14. 2004 Parking Bond Trustee** means Wells Fargo, as indenture trustee
5 under the 2004 Parking Bonds Indenture, or any successor indenture trustee thereunder.

6 **15. 2004 Parking Bonds** means the Stockton Public Financing Authority Lease
7 Revenue Bonds, Series 2004, (Parking and Capital Projects), issued on June 25, 2004, in the
8 original aggregate principal amount of \$32,785,000.

9 **16. 2006 SEB Bond Insurance Policy** means the Financial Guaranty Insurance
10 Policy No. 47756(1) issued by NPF, as successor to MBIA Insurance Corporation, with respect
11 to the 2006 SEB Bonds.

12 **17. 2006 SEB Bond Trustee** means Wells Fargo, as indenture trustee under
13 the 2006 SEB Bonds Indenture, or any successor indenture trustee thereunder.

14 **18. 2006 SEB Bonds** means the Stockton Public Financing Authority 2006
15 Lease Revenue Refunding Bonds, Series A, issued on April 6, 2006, in the original aggregate
16 principal amount of \$13,965,000.

17 **19. 2006 SEB Indenture** means the Indenture of Trust, dated as of March 1,
18 2006, by and between the Financing Authority and the 2006 SEB Bond Trustee, relating to the
19 2006 SEB Bonds.

20 **20. 2007 Office Building Bond Insurance Policy** means, collectively, the
21 Financial Guaranty Insurance Policy No. D-2007-293 and the Financial Guaranty Insurance Policy
22 No. D-2007-295, each issued by Assured Guaranty with respect to the 2007 Office Building
23 Bonds (Series A) and the 2007 Office Building Bonds (Series B), respectively.

24 **21. 2007 Office Building Bond Trustee** means Wells Fargo as the indenture
25 trustee under the 2007 Office Building Bonds Indenture, or any successor indenture trustee
26 thereunder.

27 **22. 2007 Office Building Bonds** means, collectively, the 2007 Series A Bonds
28 and the 2007 Series B Bonds.

1 **23. 2007 Office Building Bonds Indenture** means the Indenture of Trust,
2 dated as of November 1, 2007, by and between the Financing Authority and the 2007 Office
3 Building Bond Trustee, relating to the 2007 Office Building Bonds.

4 **24. 2007 Series A Bonds** means the Stockton Public Financing Authority
5 Variable Rate Demand Lease Revenue Bonds, 2007 Series A (Building Acquisition Financing
6 Project), issued on November 29, 2007, in the original aggregate principal amount of \$36,500,000.

7 **25. 2007 Series B Bonds** means the Stockton Public Financing Authority
8 Taxable Variable Rate Demand Lease Revenue Bonds, 2007 Series B (Building Acquisition
9 Financing Project), issued on November 29, 2007, in the original aggregate principal amount of
10 \$4,270,000.

11 **26. 2009 Golf Course/Park Bond Trustee** means Wells Fargo as the indenture
12 trustee under the 2009 Golf Course/Park Bonds Indenture, or any successor indenture trustee
13 thereunder.

14 **27. 2009 Golf Course/Park Bonds** means the Stockton Public Financing
15 Authority Lease Revenue Bonds, 2009 Series A (Capital Improvement Projects), issued on
16 September 9, 2009, in the original aggregate principal amount of \$35,080,000.

17 **28. 2009 Golf Course/Park Bonds Indenture** means the Indenture of Trust,
18 dated as of September 1, 2009, by and between the Financing Authority and the 2009 Golf
19 Course/Park Bond Trustee, relating to the 2009 Golf Course/Park Bonds.

20 **29. 400 E. Main Office Building Property** means the office building located
21 at 400 E. Main Street in the City.

22 **30. AB 506** means Assembly Bill 506, codified at California Government Code
23 53760 *et seq.*

24 **31. Additional Tax Increment Revenues** has the meaning set forth in the
25 definition of Arena Lease Back Transaction.

26 **32. Administrative Claim** means the costs or expenses of administration of the
27 Chapter 9 Case not already paid by the City, allowed under section 503(b) and entitled to priority
28 under section 507(a)(2) to the extent made applicable in Chapter 9: (i) which the City agrees is an

1 Allowed administrative expense; or (ii) which the Bankruptcy Court determines is an Allowed
2 administrative expense. The City's consent to the Bankruptcy Court adjudicating Administrative
3 Claim status is given without the City in any way consenting or agreeing that Claims for
4 postpetition obligations of the City are or would be entitled to status as Administrative Claims as
5 "the actual necessary costs and expenses of preserving the estate" under section 503(b), and the
6 City reserves its right to maintain that such Claims would instead constitute Other Postpetition
7 Claims.

8 **33. Allowed means,**

9 (a) with reference to any Claim, a Claim that

10 (i) has been listed on the list of creditors filed by the City, as
11 such list may be amended from time to time pursuant to Bankruptcy Rule 1009; is not listed as
12 unliquidated, contingent or disputed; and for which no contrary proof of claim has been filed
13 (subject to objection as set forth in the next subsection);

14 (ii) is asserted in a proof of claim filed in compliance with
15 section 501 and any applicable orders of the Bankruptcy Court or listed in the list of creditors filed
16 by the City and as to which: (A) no objection has been, or subsequently is, filed within the
17 deadline established pursuant to Section X(A) of the Plan (as such deadline may be extended by

13 **37. Ambac Settlement Agreement** means the Stipulation and Settlement
14 Agreement, dated as of February 26, 2013, by and among the City, the Financing Authority, the

11 vote on the Plan the Plan Supplement [Dkt. No. 1236] and the Supplemental Plan Supplement
12 [Dkt. No. 1259]. Further, the City will electronically file with the Bankruptcy Court and Rust
13 Omni will serve in CD-ROM format by U.S. mail on all parties entitled to vote on the Plan the
14 Second Supplemental Plan Supplement. The City has made (and in the case of the Second
15 Supplemental Plan Supplement, will make) each of these documents electronically available on its
16 website. The exhibits and schedules contained in these documents are incorporated into, and are a
17 part of, the Plan as if set forth herein.

18 **II. TREATMENT AND DEADLINE FOR THE ASSERTION OF ADMINISTRATIVE**

21 Except to the extent that the holder of an Allowed Administrative Claim agrees to a
22 different treatment, the City or its agent shall pay to each holder of an Allowed Administrative
23 Claim, in full satisfaction, release, and discharge of such Allowed Administrative Claim, Cash in an
24 amount equal to such Allowed Administrative Claim on the later of (i) the Effective Date or (ii) the
25 date on which such Claim becomes an Allowed Administrative Claim, or as soon thereafter as is
26 practicable.

27 **B. Treatment of Professional Claims.**

28 Pursuant to section 943(b)(3), all amounts paid following the Effective Date or to
be paid following the Effective Date for services or expenses in the Chapter 9 Case or incident to

1 this Plan must be disclosed to the Bankruptcy Court and must be reasonable. There shall be paid
2 to each holder of a Professional Claim, in full satisfaction, release, and discharge of such Claim,
3 Cash in an amount equal to that portion of such Claim that the Bankruptcy Court approves as
4 reasonable, on or as soon as reasonably practicable following the date on which the Bankruptcy
5 Court enters a Final Order determining such reasonableness. The City, in the ordinary course of
6 its business, and without the requirement for Bankruptcy Court approval, may pay for professional
7 services rendered and costs incurred following the Effective Date.

8 **C. Priority Claims in Chapter 9.**

9 The only priority claims incorporated into chapter 9 through section 901 are
10 Administrative Claims allowed under section 503(b) and entitled to priority under section
11 507(a)(2). The treatment of all such Administrative Claims is set forth immediately above in
12 Sections II(A) and II(B). No other kinds of priority claims set forth in section 507 are recognized
13 in chapter 9 cases, and Claims that are not Administrative Claims herein and that would constitute
14 administrative expenses in a case under another chapter of the Bankruptcy Code, including Other
15 Postpetition Claims, are treated in chapter 9 and in this Plan as General Unsecured Claims.

16
17 **D. Deadline for the Filing and Assertion of Other Postpetition Claims,
Administrative Claims and Professional Claims.**

18 **All proofs of claim for Other Postpetition Claims arising on or after August**
19 **16, 2013, and requests for payment or any other means of preserving and obtaining**
20 **payment of Administrative Claims that have not been paid, released, or otherwise settled,**
21 **and all requests for approval of Professional Claims, must be filed with the Bankruptcy**
22 **Court and served upon the City no later than 30 days after the date on which the Notice of**
23 **Effective Date is served.** Any proof of claim for Other Postpetition Claims, or request for
24 payment of an Administrative Claim or a Professional Claim, that is not timely filed by such date
25 will be forever barred, and holders of such Claims shall be barred from asserting such Claims in
26 any manner against the City. For the avoidance of doubt, proofs of claim for Other Post-Petition
27 Claims that arose before August 16, 2013 must have been filed by August 16, 2013, in order to be
28 considered timely.

2. Treatment.

The treatment of the Class 1A Claims will be as set forth in the Ambac Settlement Agreement, which should be consulted for the precise terms of the treatment. The Plan does not modify, amend, or alter the amounts due to the holders of the 2003 Fire/Police/Library Certificates or the obligations of Ambac to pay principal or redemption price of, or interest on, the 2003 Fire/Police/Library Certificates as and when such amounts become due under the 2003 Fire/Police/Library Certificates Trust Agreement, which payments shall be made by Ambac in accordance with, and subject to, the terms of the Ambac Insurance Policy. Ambac, as the holder

1 of the Class 1A Claims, is entitled to vote to accept or reject this Plan in accordance with the Plan
2 Solicitation Order.

3 **B. Class 1B – Claims of Holders of 2003 Fire/Police/Library Certificates.**

4 **1. Impairment and Voting.**

5 Class 1B is Impaired by this Plan since the treatment of this Class will affect the
6 legal, equitable, or contractual rights of the holders of the Claims, and, accordingly, Ambac, as the
7 deemed holder of the Claims in this Class, is entitled to vote to accept or reject this Plan in
8 accordance with the Plan Solicitation Order.

9 **2. Treatment.**

10 The treatment of the Class 1B claimants, the 2003 Fire/Police/Library Certificates
11 holders, is identical to the treatment of Ambac, the Class 1A claimant.

18 accordance with the Plan Solicitation Order.

19 **2. Treatment.**

20 On the Effective Date, the City will assume the SEB Lease Back and the SEB
21 Lease Out under section 365(a) pursuant to the NPFG/SEB Settlement. The finding by the
22 Bankruptcy Court that the Plan is feasible shall constitute adequate assurance of future
23 performance of the SEB Lease Back and the SEB Lease Out. The Plan does not modify, amend,
24 or alter the 2006 SEB Bonds or the obligations of NPFG to pay principal or redemption price of,
25 or interest on, the 2006 SEB Bonds as and when such amounts become due under the 2006 SEB
26 Bond Indenture, which payments shall be made by NPFG in accordance with, and subject to, the
27 terms of the 2006 SEB Bond Insurance Policy.

2. Treatment.

The treatment of the Class 3 Claims will be as set forth in the NPFG Arena Settlement, which should be consulted for the precise terms of the treatment. The Plan does not modify, amend, or alter the 2004 Arena Bonds or the obligations of NPFG to pay principal or redemption price of, or interest on, the 2004 Arena Bonds as and when such amounts become due under the 2004 Arena Bond Indenture, which payments shall be made by NPFG in accordance with, and subject to, the terms of the 2004 Parking Bond Insurance Policy. On the Effective Date, without the need to file any further motions, the Arena Lease Out and the Arena Lease Back shall be assumed, subject to the modification of the City's obligations pursuant to the terms of the NPFG Arena Settlement.

E. Class 4 – Parking Structure Claims of the 2004 Parking Bond Trustee/NPFG – 2004 Parking Bonds.

1. Impairment and Voting.

Class 4 is Impaired by this Plan since the treatment of this Class will affect the legal, equitable, or contractual rights of the holders of the Claims, and, accordingly, NPFG, as the deemed holder of the Claims in this Class, is entitled to vote to accept or reject this Plan in accordance with the Plan Solicitation Order.

2. Treatment.

The treatment of the Class 4 Claims will be as set forth in the NPFG Parking Settlement Documents, which should be consulted for the precise terms of the treatment. On the Effective Date, without the need to file any further motions, the Parking Structure Lease Out shall

1 be assumed, and any and all rights and obligations thereunder shall be assigned to the Parking
2 Authority, with the obligations of the City limited by the NPMG Parking Settlement Documents.
3 To the extent the City determines it is necessary or desirable to do so, in addition to those
4 executory contracts being assigned to the Parking Authority by virtue of the above, the City
5 reserves the right to file before or after the Effective Date a motion in which it will seek authority
6 to assign to the Parking Authority certain executory contracts and unexpired leases executed in
7 connection with the Parking Structure Lease Out that are assumed under the Plan.

26 Class 6 is Impaired by this Plan since the treatment of this Class will affect the legal,
27 equitable, or contractual rights of the holders of the Claims, and, accordingly, Assured Guaranty,
28 as the deemed holder of the Claims in this Class, is entitled to vote to accept or reject this Plan in
accordance with the Plan Solicitation Order. The Plan does not modify, amend or alter the

1 Pension Obligation Bonds or the obligations of Assured Guaranty to pay principal or redemption
2 price of, or interest on Pension Obligation Bonds as and when such amounts become due under
3 Pension Obligation Bonds Indenture, which payments shall be made by Assured Guaranty in
4 accordance with, and subject to, the terms of the Pension Obligation Bonds Insurance Policy.

7 **2. Treatment.**

8 The treatment of the Class 6 Claims will be as set forth in the Assured Guaranty
9 Settlement, which should be consulted for the precise terms of the treatment. The Plan does not
10 modify, amend, or alter the Pension Obligation Bonds or the obligations of Assured Guaranty to
11 pay principal or redemption price of, or interest on Pension Obligation Bonds as and when such
12 amounts become due under Pension Obligation Bonds Indenture, which payments shall be made
13 by Assured Guaranty in accordance with, and subject to, the terms of the Pension Obligation
14 Bonds Insurance Policy.

15 **H. Class 7 – Claims of DBW.**

16 **1. Impairment and Voting.**

17 Class 7 is Impaired by this Plan since the treatment of this Class will affect the legal,
18 equitable, or contractual rights of the holders of the Claims, and, accordingly, the holder of the
19 Claims in this Class is entitled to vote to accept or reject this Plan in accordance with the Plan
20 Solicitation Order.

21 **2. Treatment.**

22 The treatment of the Class 7 Claims will be as set forth in the DBW Settlement
23 Agreement. The General Fund will have no obligation to pay debt service on this obligation, or to
24 reimburse operating expenses to DBW should DBW take over operations of the Marina Project.
25 DBW will retain its pledge of rents and leases generated from the Marina Project. However, the
26 pledge of gross revenues will be converted to a pledge of revenues net of all reasonable and direct
27 operating expense of the Marina Project, calculated on a fiscal year basis ending June 30 of each
28 year pursuant to section 928(b). Upon no less than 120 days notice to the City, DBW may take

1 possession of the facilities comprising the Marina Project, and if DBW elects to continue
2 operations of the Marina Project, DBW will be responsible for payment of all operating expenses
3 of the Marina Project. If DBW should elect to continue operations, DBW shall provide adequate
4 security of the premises. The General Fund shall have no liability, directly or indirectly, for the
5 Claims of DBW, and the City may decide at any time to cease subsidizing the operating deficits of
6 the operation of the Marina Project. DBW has stated to the City an interest in exercising its
7 remedy of taking possession of the Marina Project. The real property that is the subject of the
8 Marina Project shall be that real property described in Exhibit A to this Plan, and should DBW
9 exercise its remedy of taking possession of the Marina Project, DBW shall succeed to possession
10 and control only over the real property set forth in Exhibit A.

11 **I. Class 8 – SCC 16 Claims.**

12 **1. Impairment and Voting.**

13 Class 8 is not Impaired by this Plan since the treatment of this Class will not affect
14 the legal, equitable, or contractual rights of the holders of the Claims, and, accordingly, the holders
15 of the Claims in this Class are not entitled to vote to accept or reject this Plan in accordance with
16 the Plan Solicitation Order.

17 **2. Treatment.**

18 To the extent SCC 16 has any offset rights arising under the Construction
19 Agreement, SCC 16 shall apply any such offsets against amounts owing under the SCC 16
20 Promissory Note. On the Effective Date, pursuant to the Plan, without the need to file any further

18 Restricted Revenue Bond and Notes Payable Obligations. The City's Restricted
19 Revenue Bond and Notes Payable Obligations are secured by a pledge of and lien on revenues of
20 various of the City's systems and enterprises, which are restricted revenues pursuant to the
21 California Constitution, and are "special revenues" as defined in section 902(2). These revenues
22 are not a part of or available to the General Fund, and the General Fund is not obligated to make
23 any payment on the Restricted Revenue Bond and Note Payable Obligations. The City may
24 transfer amounts from the restricted revenues to the General Fund only to pay costs which are
25 incurred by the General Fund to provide the facility or enterprise-related services and which are
26 allocated to the enterprises on a reasonable basis in accordance with the City's accounting and
27 allocation policies and pursuant to the provisions of the relevant documents related to the
28 Restricted Revenue Bonds and Notes Payable Obligations. Such transfers are treated by the
facility or enterprise as operation and maintenance expenses. The City will continue to apply

1 restricted revenues to pay the Restricted Revenue Bond and Notes Payable Obligations as required
2 by the terms of such obligations.

25 purpose or be transferred to the General Fund. The General Fund is not obligated to pay debt
26 service on the Special Assessment and Special Tax Obligations. The City will continue to apply
27 revenues from the applicable special assessments and special taxes to pay the Special Assessment
28 and Special Tax Obligations as required by the terms of such obligations.

All other General Unsecured Claims shall receive cash on the Effective Date in the amount equal to a percentage of the Allowed amount of such Claims, which percentage equals the Unsecured Claim Payout Percentage, or such other amount as is determined by the Bankruptcy Court before confirmation of this Plan to constitute a pro-rata payment on such other General Unsecured Claims; *provided, however*, that the dollar amount to be paid on account of General Unsecured Claims other than the Retiree Health Benefit Claims on the Effective Date shall not exceed \$500,000. A. Voting of Claims.

Each holder of an Allowed Claim (and, as applicable as specified herein, Ambac, NPMG, and Assured Guaranty) classified into Classes 1A, 1B, 3, 4, 5, 6, 7, 9, 12, 14, 18, 19, and 20 shall be entitled to vote each such Claim to accept or reject this [Plan. With respect to any Class of Impaired Claims that fails to accept this Plan, the City, as proponent of this Plan, will request that the Bankruptcy Court nonetheless confirm this Plan pursuant to the so-called “cramdown” powers set forth in section 1129(b).

VI. TREATMENT OF EXECUTORY CONTRACTS AND UNEXPIRED LEASES

A. Assumption of Executory Contracts and Unexpired Leases.

Without the need to file any further motions, [in addition to the assumption of equipment leases in Class 16,](#) the City elects to assume and will assume as of the Effective Date all executory contracts and unexpired leases to which it is a party (and will assign certain of those executory contracts as set forth in the Plan) except: (i) for those unexpired leases and executory contracts specified in subsection C. below; ~~-(ii) for the equipment leases in Class 16;~~ and ~~(iii)~~ as otherwise provided in this Plan. Further, as set forth in Section IV.E.2 dealing with the treatment of the Class 4 Claims, and in addition to the assignment described and effected therein, to the extent the City determines it is necessary or desirable to do so, the City reserves the right to file before or after the Effective Date a motion in which it will seek authority to assign to the Parking Authority certain executory contracts and unexpired leases executed in connection with the Parking Structure Lease Out that are assumed under the Plan.

B. Cure Payments.

The Bankruptcy Court shall resolve all disputes regarding: (i) the amount of any cure payment to be made in connection with the assumption of any contract or lease; (ii) the ability of the City to provide “adequate assurance of future performance” within the meaning of section 365 under the contract or lease to be assumed; and (iii) any other matter pertaining to such assumption and assignment. Any party to an executory contract or unexpired lease that is to be

1 assumed by the City that asserts that any payment or other performance is due as a condition to
 2 the proposed assumption shall file with the Bankruptcy Court and serve upon the City a written
 3 statement and accompanying declaration in support thereof, specifying the basis for its Claim

D. Claims Arising From Rejection.

Proofs of claim arising from the rejection of executory contracts or unexpired leases must be filed with the Bankruptcy Court and served on the City no later than 28 days after the date on which notice of entry of the order approving the Rejection Motion is served on the parties to the executory contracts and expired leases subject to the Rejection Motion. Any Claim for which a proof of claim is not filed and served within such time will be forever barred and shall not be enforceable against the City or its assets, properties, or interests in property. Unless otherwise ordered by the Bankruptcy Court, all such Claims that are timely filed as provided herein shall be classified into Class 12 (General Unsecured Claims) and treated accordingly.

VII. IMPLEMENTATION AND MEANS FOR IMPLEMENTATION OF THIS PLAN

Following the Effective Date, the City will continue to operate pursuant to the City Charter, the California Constitution, and other applicable laws.

Pursuant to the Rejection Motion, the City will reject certain (i) unexpired leases and (ii) executory contracts, including, without limitation, the Ports License Agreement, if the City and the Ports have been unable to reach an agreement on the Ports Settlement Documents prior to 120 days after the Effective Date.

On the Effective Date, pursuant to the Plan, without the need to file any further motions, the City will assume, among other leases, (i) the SEB Lease Out and the SEB Lease Back; and (ii) the Arena Lease Out and the Arena Lease Back, as modified by the NPMG Arena Settlement. Further, pursuant to the NPMG Parking Settlement, the City will assign the Parking Structure Lease Out and the Parking Structure Lease Back to the Parking Authority of the City of Stockton, and the Parking Authority of the City of Stockton will assume all of the City's obligations under the Parking Structure Lease Out and the Parking Structure Lease Back. On the

1 Effective Date, pursuant to the Plan, without the need to file any further motions, the SCC 16
2 Lease shall be assumed, and any and all rights and obligations thereunder shall be assigned to the
3 Parking Authority. On the Effective Date any and all rights of the City under the SCC 16
4 Settlement, the Construction Agreement shall be assumed and assigned by the City to the Parking

6 **VIII. RESERVATION OF THE CITY'S RIGHTS OF ACTION**

7 All of the City's claims, causes of action, rights of recovery, rights of offset,
8 recoupment rights to refunds, and similar rights shall be retained by the City. The failure to list in
9 the Disclosure Statement any potential or existing Right of Action retained by the City is not
10 intended to and shall not limit the rights of the City to pursue any such action. Unless a Right of
11 Action is expressly waived, relinquished, released, compromised, or settled (in this Plan or
12 otherwise), the City expressly reserves all Rights of Action for later adjudication and, as a result,
13 no preclusion doctrine, including the doctrines of res judicata, collateral estoppel, issue preclusion,
14 claim preclusion, estoppel (judicial, equitable, or otherwise), or laches, shall apply to such Rights
15 of Action upon or after the confirmation or consummation of this Plan or the Effective Date. In
16 addition, the City expressly reserves the right to pursue or adopt against any other Entity any
17 claims alleged in any lawsuit in which the City is a defendant or an interested party.

18 **IX. DISTRIBUTIONS**

19 **A. Distribution Agent.**

20 On or after the Effective Date, the City may retain one or more agents (including
21 Rust Omni) to perform or assist it in performing the distributions to be made pursuant to this
22 Plan, which agents may serve without bond. The City may provide reasonable compensation to
23 any such agent(s) without further notice or Bankruptcy Court approval.

24 **B. Delivery of Distributions.**

25 All distributions to any holder of an Allowed Claim shall be made at the address of
26 such holder as set forth in the books and records of the City or its agents, unless the City has been
27 notified by such holder in a writing that contains an address for such holder different from the
28 address reflected in the City's books and records. All such notifications of address changes and all

4 **C. Distributions of Unclaimed Property.**

5 If any distribution to any holder of a Claim is returned to the City or its agent as
6 undeliverable, no further distributions shall be made to such holder unless and until the City is
7 notified in writing of such holder's then-current address. Any unclaimed distributions shall be set
8 aside and held in a segregated account to be maintained by the City pursuant to the terms of this
9 Plan. No later than 63 days after the date of the first distributions under the Plan, the City shall file
10 with the Bankruptcy Court a list of unclaimed distributions, together with a schedule that identifies
11 the name and last-known addresses of the holders of any unclaimed distributions. The City shall
12 not be required to make any further attempt to locate the holders of any unclaimed distributions.
13 Any distribution under the Plan that remains unclaimed after 91 days following the date of the first
14 distributions under the Plan (including, without limitation, because the distribution made to the last
15 known address is returned as undeliverable), shall be deemed not to have been made and, together
16 with any accrued interest or dividends earned thereon, shall be transferred to and vest in the City
17 for any use as the City sees fit. The City shall not be obligated to make any further distributions on
18 account of the Claim with respect to which such distribution was made, and such Claim shall be
19 treated as a Disallowed Claim. Nothing contained herein shall affect the discharge of the Claim
20 with respect to which such distribution was made, and the
21 holder of such Claim shall be forever barred from enforcing such Claim against the City or its
22 assets, estate, properties, or interests in property.

23 **D. Distributions of Cash.**

24 Any payment of Cash to be made by the City or its agent pursuant to this Plan shall
25 be made by check drawn on a domestic bank or by wire transfer, at the sole option of the City.

E. Timeliness of Payments.

Any payments or distributions to be made pursuant to this Plan shall be deemed to be timely made if made within 14 days after the dates specified in this Plan. Whenever any distribution to be made under this Plan shall be due on a day that is not a Business Day, such distribution instead shall be made, without interest on such distribution, on the immediately succeeding Business Day, but shall be deemed to have been timely made on the date due.

F. Compliance with Tax, Withholding, and Reporting Requirements.

The City shall comply with all tax, withholding, reporting, and like requirements imposed on it by any government unit, including without limitation, any payments related to CalPERS's required pension obligations, and all distributions pursuant to this Plan shall be subject to such withholding and reporting requirements. In connection with each distribution with respect to which the filing of an information return (such as Internal Revenue Service Forms W-2, 1099, or 1042) or withholding is required, the City shall file such information return with the Internal Revenue Service and provide any required statements in connection therewith to the recipients of such distribution, or effect any such withholding and deposit all moneys so withheld to the extent required by law. With respect to any entity from whom a tax identification number, certified tax identification number, or other tax information which is required by law to avoid withholding has not been received by the City, the City at its sole option may withhold the amount required and distribute the balance to such entity or decline to make such distribution until the information is received.

///

G. Time Bar to Cash Payments.

Checks issued by the City on account of Allowed Claims shall be null and void if not negotiated within 91 days from and after the date of issuance thereof. Requests for reissuance of any check shall be made directly to the City by the holder of the Allowed Claim with respect to which such check originally was issued. Any claim in respect of such a voided check must be made on or before the second anniversary of the Effective Date. After such date, all Claims in

1 respect of voided checks will be discharged and forever barred and the City will retain all moneys
2 related thereto.

3 **H. No De Minimis Distributions.**

4 Notwithstanding any other provision of this Plan, no Cash payment of less than \$10
5 will be made by the City on account of any Allowed Claim.

6 **I. No Distributions on Account of Disputed Claims.**

7 Notwithstanding anything to the contrary in this Plan, no distributions shall be made
8 on account of any part of any Disputed Claim until such Claim becomes Allowed (and then only to
9 the extent so Allowed). Distributions made after the Effective Date in respect of Claims that were
10 not Allowed as of the Effective Date (but which later became Allowed) shall be deemed to have
11 been made as of the Effective Date.

12 **J. No Postpetition Accrual.**

13 Unless otherwise specifically provided in this Plan or Allowed by order of the
14 Bankruptcy Court, the City will not be required to pay to any holder of a Claim any interest,
15 penalty, or late charge accruing with respect to such claim on or after the Petition Date. This
16 provision does not apply to holders of the 2003 Fire/Police/Library Certificates, the 2004 Arena
17 Bonds, the 2004 Parking Bonds, the 2006 SEB Bonds, the 2007 Office Building Bonds, and the
18 2009 Golf Course/Park Bonds, which bonds are not themselves obligations of the City and
19 therefore are not Claims. Therefore, the holders of such bonds and certificates will retain all of
20 their rights to postpetition interest, penalties, and late charges. This provision also does not apply
21 to Assured Guaranty, as the deemed holder of the Pension Obligation Bonds Claims, which shall
22 receive interest on any payments required of the City by the Assured Guaranty Settlement
23 Documents on account of such Pension Obligation Bonds Claims, which payments are delayed by
24 a failure to satisfy or waive the conditions to the Effective Date. Any such delayed payments shall
25 accrue interest at the rate specified in the Assured Guaranty Settlement Documents.

26 **K. CalPERS Pension Plan.**

27 Except as set forth in Section IX(F), this Section IX shall not apply to the CalPERS
28 Pension Plan.

4 **X. DISPUTED CLAIMS; OBJECTIONS TO CLAIMS; PROSECUTION OF**
5 **OBJECTIONS TO DISPUTED CLAIMS**

6 **A. Claims Objection Deadline; Prosecution of Objections.**

7 The City will have the right to object to the allowance of Claims filed with the
8 Bankruptcy Court with respect to which liability or allowance is disputed in whole or in part.
9 Unless otherwise ordered by the Bankruptcy Court, the City must file and serve any such
10 objections to Claims by not later than 182 days after the Effective Date (or, in the case of Claims
11 lawfully filed after the Effective Date, by not later than 182 days after the date of filing of such
12 Claims).

13 **B. Payments and Distributions with Respect to Disputed Claims.**

14 After the Effective Date has occurred, at such time as a Disputed Claim becomes an
15 Allowed Claim, in whole or in part, the City or its agent will distribute to the holder thereof the
16 distributions, if any, to which such holder is then entitled under this Plan. Such distributions, if
17 any, will be made as soon as practicable after the date that the order or judgment of the
18 Bankruptcy Court allowing such Disputed Claim becomes a Final Order (or such other date as the
19 Claim becomes an Allowed Claim), but in no event more than 63 days thereafter. Unless
20 otherwise specifically provided in this Plan or Allowed by order of the Bankruptcy Court, no
21 interest will be paid on Disputed Claims that later become Allowed Claims.

22 **XI. EFFECT OF CONFIRMATION**

23 **A. Discharge of the City.**

24 Pursuant to section 944, upon the Effective Date, the City will be discharged from
25 all Debts of the City and Claims against the City other than (i) any Debt specifically and expressly
26 excepted from discharge by this Plan or the Confirmation Order, or (ii) any Debt owed to an entity
27 that, before the Confirmation Date, had neither notice nor actual knowledge of the Chapter 9
28 Case. The rights afforded in the Plan and the treatment of all holders of Claims, whether such
Claims are Impaired or Unimpaired under the Plan, will be in exchange for and in complete

1 satisfaction, discharge, and release of all Claims of any nature whatsoever arising on or before the
2 Effective Date, known or unknown, including any interest accrued or expenses incurred thereon
3 from and after the Petition Date, whether against the City or any of its properties, assets, or
4 interests in property. Except as otherwise provided herein, upon the Effective Date, all
5 Pre-Confirmation Date Claims will be and shall be deemed to be satisfied, discharged, and released
6 in full, be they Impaired or Unimpaired under this Plan. For the avoidance of doubt, as provided
7 in Class 15 herein, nothing in the Plan discharges, releases, or impairs obligations of the City
8 under the CalPERS Pension Plan, and CalPERS and the CalPERS Pension Plan Participants
9 retain all of their rights and remedies under applicable nonbankruptcy law with respect to
10 the CalPERS Pension Plan.

11 Notwithstanding any other provision of this Plan or the Confirmation Order, the
12 City's obligations pursuant to the Contracts For Loan Guarantee shall remain extant and
13 enforceable and not subject to discharge pursuant to section 944; *provided, however*, that the City
14 retains all defenses to the enforceability of any such obligations under applicable nonbankruptcy
15 law.

16 **B. Injunction.**

17 Except as otherwise expressly provided in this Plan, all entities who have held,
18 hold, or may hold Pre-Confirmation Date Claims shall be permanently enjoined from and after the
19 Confirmation Date from: (i) commencing or continuing in any manner any action or other
20 proceeding of any kind with respect to any such Pre-Confirmation Date Claim against the City or
21 its property; (ii) enforcing, attaching, collecting, or recovering by any manner or means any
22 judgment, award, decree, or order against the City or its property with respect to such
23 Pre-Confirmation Date Claims; (iii) creating, perfecting, or enforcing any lien or encumbrance of
24 any kind against the City or its property; and (iv) asserting any right of setoff, subrogation, or
25 recoupment of any kind against any obligation due to the City with respect to any such Pre-
26 ~~///~~Confirmation Date Claim, except as otherwise permitted by section 553. For the avoidance of
27 doubt, nothing in the Plan enjoins CalPERS or any CalPERS Pension Plan Participant with
28 respect to the CalPERS Pension Plan.

3 **C. Term of Existing Injunctions or Stays.**

4 Unless otherwise provided, all injunctions or stays provided for in the Chapter 9
5 Case pursuant to sections 105, 362, or 922, or otherwise, and in existence on the Confirmation
6 Date, will remain in full force and effect until the Effective Date.

7 **D. Exculpation.**

8 Except with respect to obligations specifically arising pursuant to or preserved in
9 this Plan, including but not limited to the Insurance Policies, no Exculpated Party shall have or
10 incur, and each Exculpated Party is hereby released and exculpated from, any claim, obligation,
11 cause of action or liability for any claim in connection with or arising prior to or on the Effective
12 Date for any act taken or omitted to be taken in connection with, or related to, (i) the
13 administration of the Chapter 9 Case, (ii) the negotiation, pursuit, confirmation, solicitation of
14 votes for, consummation or implementation of the Plan, (iii) the administration of the Plan or
15 property to be distributed under the Plan, (iv) the AB 506 process, (v) any document, release,
16 contract, or other instrument entered into in connection with, or relating to, the Plan or the
17 settlements referenced within the Plan or (vi) any other transaction contemplated by, or entered
18 into, in connection with the Plan; *provided, however*, that nothing in this Section XI(D) shall be
19 deemed to release or exculpate any Exculpated Party for its willful misconduct or gross
20 negligence. In all respects, each Exculpated Party shall be entitled to reasonably rely upon the
21 advice of counsel with respect to its duties and responsibilities pursuant to the Plan.

22 **E. Releases Among Releasing Parties and Released Parties.**

23 EFFECTIVE AS OF THE EFFECTIVE DATE, FOR GOOD AND VALUABLE
24 CONSIDERATION PROVIDED BY EACH OF THE RELEASED PARTIES, THE
25 ADEQUACY OF WHICH IS HEREBY CONFIRMED, TO THE FULLEST EXTENT
26 PERMISSIBLE UNDER APPLICABLE LAW, (i) THE CITY AND EACH OF ITS RELATED
27 PERSONS (COLLECTIVELY, THE “**CITY RELEASING PARTIES**”) SHALL, AND SHALL
28 BE DEEMED TO, COMPLETELY, CONCLUSIVELY, ABSOLUTELY,

1 UNCONDITIONALLY, IRREVOCABLY, AND FOREVER RELEASE, WAIVE, VOID,
2 EXTINGUISH, AND DISCHARGE EACH AND ALL OF THE RELEASED PARTIES (AND
3 EACH SUCH RELEASED PARTY SO RELEASED SHALL BE DEEMED FOREVER
4 RELEASED, WAIVED AND DISCHARGED BY THE CITY RELEASING PARTIES) AND
5 THEIR RESPECTIVE PROPERTIES AND RELATED PERSONS; AND (ii) EACH OF NCFG,
6 ASSURED GUARANTY, AMBAC, THE INDENTURE TRUSTEE IN ALL ITS CAPACITIES
7 (EXCEPT IN ITS CAPACITY AS THE 2009 GOLF COURSE/PARK BOND TRUSTEE)
8 (COLLECTIVELY WITH THE CITY RELEASING PARTIES, THE “RELEASING
9 PARTIES”) SHALL, AND SHALL BE DEEMED TO, COMPLETELY, CONCLUSIVELY,
10 ABSOLUTELY, UNCONDITIONALLY, IRREVOCABLY, AND FOREVER RELEASE,
11 WAIVE, VOID, EXTINGUISH, AND DISCHARGE THE CITY (AND THE CITY SHALL BE
12 DEEMED FOREVER RELEASED, WAIVED AND DISCHARGED BY SUCH RELEASING
13 PARTIES), OF AND FROM ANY AND ALL OF THE FOLLOWING: CLAIMS, CAUSES OF
14 ACTION, LITIGATION CLAIMS, AVOIDANCE ACTIONS AND ANY OTHER DEBTS,
15 OBLIGATIONS, RIGHTS, SUITS, DAMAGES, ACTIONS, REMEDIES, JUDGMENTS, AND
16 LIABILITIES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, THE AB 506
17 PROCESS AND THE ELIGIBILITY CONTEST), WHETHER KNOWN OR UNKNOWN,
18 FORESEEN OR UNFORESEEN, LIQUIDATED OR UNLIQUIDATED, FIXED OR
19 CONTINGENT, MATURED OR UNMATURED, EXISTING AS OF THE EFFECTIVE DATE
20 OR THEREAFTER ARISING, IN LAW, AT EQUITY, WHETHER FOR TORT, CONTRACT,
21 OR OTHERWISE, BASED IN WHOLE OR IN PART UPON ANY ACT OR OMISSION,
22 TRANSACTION, EVENT OR OTHER OCCURRENCE OR CIRCUMSTANCES EXISTING
23 OR TAKING PLACE PRIOR TO OR ON THE EFFECTIVE DATE ARISING FROM OR
24 RELATED IN ANY WAY IN WHOLE OR IN PART TO THE CITY OR ITS ASSETS AND
25 PROPERTY, THE CHAPTER 9 CASE, THE DISCLOSURE STATEMENT, THIS PLAN OR
26 THE SOLICITATION OF VOTES ON THIS PLAN THAT SUCH RELEASING PARTY
27 WOULD HAVE BEEN LEGALLY ENTITLED TO ASSERT (WHETHER INDIVIDUALLY
28 OR COLLECTIVELY) OR THAT ANY HOLDER OF A CLAIM OR EQUITY INTEREST OR

1 OTHER ENTITY WOULD HAVE BEEN LEGALLY ENTITLED TO ASSERT FOR OR ON
2 BEHALF OF SUCH RELEASING PARTY (WHETHER DIRECTLY OR DERIVATIVELY)
3 AGAINST ANY OF THE RELEASED PARTIES OR THE CITY, AS APPLICABLE;
4 *PROVIDED, HOWEVER*, THAT THE FOREGOING PROVISIONS OF THIS RELEASE
5 SHALL NOT OPERATE TO WAIVE OR RELEASE (i) ANY CAUSES OF ACTION, CLAIMS
6 OR AGREEMENTS EXPRESSLY SET FORTH IN AND/OR PRESERVED BY THIS PLAN
7 OR ANY PLAN SUPPLEMENT, INCLUDING BUT NOT LIMITED TO THE INSURANCE
8 POLICIES; AND/OR (ii) THE RIGHTS OF SUCH RELEASING PARTY TO ENFORCE THIS
9 PLAN AND THE CONTRACTS, INSTRUMENTS, RELEASES, AND OTHER
10 AGREEMENTS OR DOCUMENTS DELIVERED UNDER OR IN CONNECTION WITH
11 THIS PLAN OR ASSUMED PURSUANT TO THIS PLAN OR ASSUMED PURSUANT TO
12 FINAL ORDER OF THE BANKRUPTCY COURT. THE FOREGOING RELEASE SHALL BE
13 EFFECTIVE AS OF THE EFFECTIVE DATE WITHOUT FURTHER NOTICE TO OR
14 ORDER OF THE BANKRUPTCY COURT, ACT OR ACTION UNDER APPLICABLE LAW,
15 REGULATION, ORDER, OR RULE OR THE VOTE, CONSENT, AUTHORIZATION OR
16 APPROVAL OF ANY PERSON.

17 **F. Good Faith Compromise.**

18 Pursuant to Bankruptcy Rule 9019, to the extent applicable, and in consideration
19 for the distributions and other benefits provided under this Plan, the provisions of this Plan,
20 including the exculpation and release provisions contained in this Article XI, constitute a good
21 faith compromise and settlement of all Claims, causes of action or controversies relating to the
22 rights that a holder of a Claim may have with respect to any Claim against the City, any
23 distribution to be made pursuant to the Plan on account of any such Claim and any and all Claims
24 or causes of action of any party arising out of or relating to the AB 506 Process or the Eligibility
25 Contest. The entry of the Confirmation Order constitutes the Bankruptcy Court's approval, as of
26 the Effective Date, of the compromise or settlement of all such Claims or controversies and the
27 Bankruptcy Court's finding that all such compromises or settlements are in the best interests of the
28 City and the holders of Claims, and are fair, equitable, and reasonable.

3 **XII. RETENTION OF AND CONSENT TO JURISDICTION**

4 Following the Effective Date, the Bankruptcy Court shall retain and have exclusive
5 jurisdiction over any matter (i) arising under the Bankruptcy Code and relating to the City, (ii)
6 arising in or related to the Chapter 9 Case or this Plan, and (iii) otherwise for the following:

7 1. to resolve any matters related to the assumption, assumption and assignment, or
8 rejection of any executory contract or unexpired lease to which the City is a party or with respect
9 to which the City may be liable, and to hear, determine and, if necessary, liquidate any Claims
10 arising therefrom;

11 2. to enter such orders as may be necessary or appropriate to implement or
12 consummate the provisions of this Plan, and all other contracts, settlement agreements,
13 instruments, releases, exculpations, and other agreements or documents related to this Plan;

14 3. to determine any and all motions, adversary proceedings, applications, and
15 contested or litigated matters that may be pending on the Effective Date or that, pursuant to this
16 Plan, may be instituted by the City after the Effective Date or that are instituted by any holder of a
17 Claim before or after the Effective Date concerning any matter based upon, arising out of, or
18 relating to the Chapter 9 Case, whether or not such action initially is filed in the Bankruptcy Court
19 or any other court;

20 4. to ensure that distributions to holders of Allowed Claims are accomplished as
21 provided herein;

22 5. to hear and determine any objections to Claims or to proofs of Claim filed, both
23 before and after the Effective Date, including any objections to the classification of any Claim, and
24 to allow, disallow, determine, liquidate, classify, estimate, or establish the priority of or secured or
25 unsecured status of any Claim, in whole or in part;

26 6. to enter and implement such orders as may be appropriate in the event the
27 Confirmation Order is for any reason stayed, revoked, modified, reversed, or vacated;

1 7. to issue such orders in aid of execution of this Plan, to the extent authorized by
2 section 1142(b);

3 8. to consider any modifications of this Plan, to cure any defect or omission, or to
4 reconcile any inconsistency in any order of the Bankruptcy Court, including the Confirmation
5 Order;

6 9. to the extent that the City elects to bring such matters before the Bankruptcy
7 Court, to hear and determine all applications for awards of compensation for services rendered and
8 reimbursement of expenses incurred prior to the Effective Date;

9 10. to hear and determine all disputes or controversies arising in connection with or
10 relating to this Plan or the Confirmation Order or the interpretation, implementation, or
11 enforcement of this Plan or the Confirmation Order or the extent of any Entity's obligations
12 incurred in connection with, released, enjoined, or exculpated under this Plan or the Confirmation
13 Order;

14 11. to issue injunctions, enter and implement other orders, or take such other actions as
15 may be necessary or appropriate to restrain interference by any entity with consummation or
16 enforcement of this Plan;

17 12. to determine any other matters that may arise in connection with or are related to
18 this Plan, the Disclosure Statement, the Confirmation Order, or any contract, instrument, release
19 or other agreement or document related to this Plan or the Disclosure Statement;

20 13. to hear any other matter for any purpose specified in the Confirmation Order that is
21 not inconsistent with the Bankruptcy Code;

22 14. to hear and determine all disputes or controversies arising in connection with or
23 relating to the terms or enforcement of any relevant agreements; and

24 15. to enter a final decree closing the Chapter 9 Case.

25 This Section XII shall not apply to any Claims, disputes, controversies, or other
26 matters arising under or in connection with the CalPERS Pension Plan.

27 **XIII. CONDITIONS PRECEDENT**

28 **A. Conditions Precedent to Confirmation.**

1 The conditions precedent to confirmation of the Plan are: (i) the entry of the
2 Confirmation Order in form and substance satisfactory to the City, and which is reasonably
3 satisfactory to Assured Guaranty, Ambac, NPMG, and the Indenture Trustee; and (ii) the approval
4 of the State of California Department of Finance of the restructuring of the Arena Pledge
5 Agreement as described in the NPMG Settlement.

6 **B. Conditions Precedent to Effective Date.**

7 The “effective date of the plan,” as used in section 1129, shall not occur, and this
8 Plan shall be of no force and effect, until the Effective Date. The occurrence of the Effective Date
9 is subject to the satisfaction (or waiver as set forth in Section XIII(C)) of the following conditions
10 precedent:

11 **1. Confirmation Order.** The Confirmation Order shall have been
12 entered, shall be in full force and effect, and shall be a Final Order (but the requirement
13 that the Confirmation Order be a Final Order may be waived by the City at any time).

14 ~~**2. Order Fixing Allowed Amount of the Golf Course/Park**~~
15 ~~**Secured Claim.**~~ ~~The Bankruptcy Court shall have entered an order fixing the amount~~
16 ~~**of the Allowed Golf Course/Park Secured Claim.**~~

17 **2. Plan Documents.** All agreements and instruments
18 contemplated by, or to be entered into pursuant to, this Plan shall be in form and
19 substance acceptable to the City (and in the case of all agreements and instruments
20 between the City and Ambac, Assured Guaranty, NPMG, and the Indenture Trustee,
21 acceptable to Ambac, Assured Guaranty, NPMG, and the Indenture Trustee,
22 respectively); shall have been duly and validly executed and delivered (including, but
23 not limited to, any documents necessary to be executed on or prior to the Effective
24 Date so as to implement the Ambac Settlement, the Assured Guaranty Settlement, and
25 the NPMG Settlement, respectively, and the satisfaction or waiver of the conditions
26 precedent to the Ambac Settlement, the Assured Guaranty Settlement, and the NPMG
27 Settlement, respectively), or deemed executed by the parties thereto; and all conditions
28 to their effectiveness shall have been satisfied or waived.

2 **3. ~~4. Authorizations, Consents, Etc.~~** The City shall have received
3 any and all authorizations, consents, regulatory approvals, rulings, no-action letters,
4 opinions, and documents that are necessary to implement the Plan and that are required
5 by law, regulation or order.

6 **4. ~~5. Timing.~~** The Effective Date shall occur on the first Business
7 Day on which the conditions set forth in Section XIII(B)(1) and (B)(2) are satisfied or
8 waived; *provided* that, unless otherwise ordered by the Bankruptcy Court, the Effective
9 Date must occur by no later than 182 days after the Confirmation Date.

10 **C. Waiver of Conditions to Effective Date.**

11 The City may waive in whole or in part any condition to effectiveness of this Plan.
12 If a condition to the occurrence of the Effective Date is the occurrence of the conditions to the
13 effectiveness of the Ambac Settlement Agreement, the Assured Guaranty Settlement, or the NPMG
14 Settlement, then such condition may not be waived without the prior written consent of Ambac,
15 Assured Guaranty, of NPMG, as applicable. Any such waiver of a condition may be effected at any
16 time, without notice or leave or order of the Bankruptcy Court and without any formal action,
17 other than the filing of a notice of such waiver with the Bankruptcy Court.

18 **D. Effect of Failure of Conditions.**

19 In the event that the conditions to effectiveness of this Plan have not been timely
20 satisfied or waived, and upon notification submitted by the City to the Bankruptcy Court, (i) the
21 Confirmation Order shall be vacated, (ii) no distributions under this Plan shall be made, (iii) the
22 City and all holders of Claims shall be restored to the status quo ante as of the day immediately
23 preceding the Confirmation Date as though the Confirmation Date never occurred, and (iv) all of
24 the City's obligations with respect to the Claims shall remain unchanged and nothing contained
25 herein shall be deemed to constitute a waiver or release of any claims by or against the City or any
26 other entity or to prejudice in any manner the rights, remedies, or claims of the City or any entity
27 in any further proceedings involving the City.

2 **E. No Admission of Liability.**

3 The Plan constitutes a settlement and compromise between and among the City and
4 various parties. The Plan shall not be deemed an admission or concession by any party with
5 respect to any factual or legal contention, right, defense, or position taken by the City.

8 **XIV. MISCELLANEOUS PROVISIONS**

9 **A. Dissolution of the Retirees Committee.**

10 On the Effective Date, the Retirees Committee shall be released and discharged of
11 and from all further authority, duties, responsibilities, and obligations relating to and arising from
12 and in connection with the Chapter 9 Case, and the Retirees Committee shall be deemed dissolved
13 and its appointment terminated.

14 **B. Severability.**

15 If any term or provision of this Plan is held by the Bankruptcy Court or any other
16 court having jurisdiction, including on appeal, if applicable, to be invalid, void, or unenforceable,
17 the Bankruptcy Court, in each such case at the election of and with the consent of the City, shall
18 have the power to alter and interpret such term or provision to make it valid or enforceable to the
19 maximum extent practicable, consistent with the original purpose of the term or provision held to
20 be invalid, void, or unenforceable, and such term or provision shall then be applicable as altered or
21 interpreted. Notwithstanding any such holding, alteration, or interpretation, the remainder of the
22 terms and provisions of this Plan shall remain in full force and effect and shall in no way be
23 affected, impaired, or invalidated by such holding, alteration, or interpretation. The Confirmation
24 Order shall constitute a judicial determination and shall provide that each term and provision of
25 this Plan, as it may have been altered or interpreted in accordance with the foregoing, is valid and
26 enforceable pursuant to its terms.

27 **C. Governing Law.**

1 Except to the extent that the Bankruptcy Code or other federal law is applicable, or
2 to the extent that an exhibit hereto or Plan Document provides otherwise, the rights, duties, and
3 obligations arising under this Plan shall be governed by, and construed and enforced in
4 ~~///~~accordance with, the laws of the State of California, without giving effect to principles of
5 conflicts of laws.

6 **D. Effectuating Documents and Further Transactions.**

7 Each of the officials and employees of the City is authorized to execute, deliver,
8 file, or record such contracts, instruments, releases, indentures, and other agreements or
9 documents and take such actions as may be necessary or appropriate to effectuate and further
10 evidence the terms and provisions of this Plan.

11 **E. Notice of Effective Date.**

12 On or before 14 days after occurrence of the Effective Date, the City or its agent
13 shall mail or cause to be mailed to all holders of Claims the Notice of the Effective Date, which
14 will inform such holders of: (a) entry of the Confirmation Order; (b) the occurrence of the
15 Effective Date; (c) the assumption and rejection of the City’s executory contracts and unexpired
16 leases pursuant to this Plan, as well as the deadline for the filing of Claims arising from such
17 rejection; (d) the deadline established under this Plan for the filing of Administrative Claims; (e)
18 the procedures for changing an address of record pursuant to Section IX; and (f) such other
19 matters as the City deems to be appropriate.
