## **City of Stockton Accepting Applications Apply for Boards, Commissions and Committees**

STOCKTON, Calif. – The City of Stockton is accepting online applications for boards and commissions at [www.stocktonca.gov/bcvacancies](http://www.stocktonca.gov/bcvacancies). The deadline for applications is Monday, July 2, 2018. The following opportunities are available:

**Arts Commission:** A fifteen (15) member commission that encourages, promotes and sponsors projects and programs that further the growth and public awareness of the visual, performing and literary arts in Stockton; offering organizational and promotional assistance to artists and art organizations; and advising the City Council on the artistic and cultural development of the City. The City is seeking to fill five (5) upcoming vacancies with terms beginning January 1, 2019, and ending December 31, 2022. The term of service is four (4) years with a two (2) term limit. The Commission meets the first Monday of each month at 5:30 p.m. To qualify, applicants must be a resident of the City of Stockton. There is no remuneration.

**Central Parking District Advisory Board:** A seven (7) member board that serves as an advisory body to the City Council and makes recommendations on rules, rates, regulations and development plans of the Central Parking District. The City is seeking to fill four (4) vacancies. The term begins immediately upon appointment and

ends June 30, 2022. The term of service is four (4) years with a two (2) term limit. Members meet once a month on the fourth Wednesday. Applicants must own real property or be an executive officer or board member of a corporation that owns property within the Central Parking District. There is no remuneration.

**City Council Salary Setting Commission:** A five (5) member commission that recommends to City Council the amount of monthly salary and benefits deemed appropriate for members of the Council, including the Mayor, for two-year periods. The City is seeking to fill two (2) upcoming vacancies with terms beginning January 1, 2019, and ending December 31, 2022. The term of service is for four (4) years with a two (2) term limit. The Commission meets between March 1 and April 30 of every odd year. To qualify, applicant must be qualified electors of the City of Stockton, remain qualified electors at all times during the term of office, and reside within the urban community of the City of Stockton. There is no remuneration.

**Civil Service/Equal Employment Commission:** A five (5) member commission that establishes suitable rules and regulations for the administration of the City's Civil Service System for classification, recruitment and testing. The Commission investigates matters related to the enforcement of such rules and regulations, hears appeals regarding the administration of the Civil Service System, and serves as the City's Equal Employment Commission. The City is seeking to fill one (1) partial term due to a resignation. The term will begin immediately upon appointment and end on June 30, 2021.

The term of service is for three (3) years. The Commission has a (2) term limit. Members meet once a month on the third Thursday of each month; the remuneration is \$25 per meeting. To qualify, applicants must be registered to vote in the City of Stockton and must not hold any other public office, place or position of employment with the City of Stockton.

**Community Development Committee:** A seven (7) member committee that acts as an advisory body to the City Council. The Committee studies Housing Department data to recommend ongoing project funding levels, reviews Department of Housing and Urban Development applications, and meets with area residents to analyze community support for newly designated areas. The City is seeking to fill one (1) partial term due to a resignation. The term will begin immediately and end on September 30, 2021, representing Council District 4. The term of service is for four (4) years with a two (2) term limit. Members meet as needed. To qualify, applicants must be a City of Stockton resident. There is no remuneration.

**Development Oversight Commission:** An eleven (11) member commission that provides a forum to enable the public and City staff to introduce, discuss and provide comments regarding City development, building and processing fee programs, and development services functions. The City is seeking to fill one (1) partial term to represent the field of construction/architecture, due to a resignation. The term will begin immediately upon appointment and end on October 20, 2019. The term of service is for five (5) years. There is no term limit. Members meet on the first Thursday of each month. There is no remuneration. To qualify, applicants must work in Stockton or with a firm/organization that

does business in Stockton and work in a field relevant to the representational categories of construction/architecture.

**Measure W Oversight Committee:** A seven (7) member committee that assures appropriate use of Measure W sales and use tax and presents an annual report to the City Council. The City is seeking to fill three (3) vacancies; two (2) terms will begin immediately upon appointment with one (1) term to end December 31, 2020, and one (1) term to end June 30, 2020. The third term will begin January 1, 2019, and end December 31, 2020. Term of service is for two (2) years with a two (2) term limit. Members meet as-needed. To qualify, applicants must be at least 28 years of age, reside within the City's geographic boundary, and not be employed by, contract, consult or do any business with the City of Stockton. There is no remuneration.

**Parks and Recreation Commission:** A ten (10) member commission that acts as the agent of the governing boards of its constituents (City of Stockton, County of San Joaquin and Unified School Districts representing Stockton, Lincoln, Lodi and Manteca). The City is seeking to fill two (2) upcoming vacancies representing lay members to begin January 1, 2019, and end December 31, 2022. Term of service is for four (4) years with a two (2) term limit. Members meet the fourth Monday of each month at 5:30 p.m. To qualify, applicants must be residents of the City of Stockton. There is no remuneration.

**Planning Commission:** A seven (7) member commission that advises and makes recommendations to the City Council on zoning, code changes, specific street and highway

plans, redevelopment plans, and conformity of capital improvements with the General Plan. The City is seeking to fill three (3) upcoming vacancies to begin in February 2019 and end January 31, 2023, representing Council Districts 1, 3 and 5. The term of service coincides with the appointing Councilmember's term. Members meet twice a month; remuneration is \$25 per meeting. To qualify, applicants must reside in the same district as the appointing councilmember.

**San Joaquin County Commission on Aging:** Serves as an advisory body on aging matters to the San Joaquin County Board of Supervisors and the Department of Aging, acts as San Joaquin County Long-Term Care Coordinating Council/Audit Day Health Care Planning Council, and advises San Joaquin County Board of Supervisors on long-term care. The City is seeking to fill one upcoming vacancy to begin September 17, 2018, and end September 16, 2021. Term of service is for three (3) years. Members meet the first Monday of each month at 1:30 p.m. except for August. Applicants must be residents of the City of Stockton. There is no remuneration.
