City of Stockton - Notice re hearings on Friday, July 6th, at 10:00 a.m.

In my email last night to virtually all of you (under cover of which I forwarded the City of Stockton's chapter 9 petition), I wrote that today the City would be filing three sets of motions, which I described briefly, and that we hoped to set them for hearing on Friday, July 6 or Monday, July 9. Earlier this evening, my secretary, Betty Ramirez, served you with three sets of pleadings in the Stockton case (No. 2012-32118). The first, sent at 6:35 p.m., forwarded the following two pleadings filed under Docket Control No. OHS-2:

 Emergency Motion for Entry of An Order (1) Directing And Approving Form of Notice; and (2) Setting Deadline for Filing Objections to Petition; and

Order Directing and Approving Form of Notice and Setting Deadline for Filing Objections to the City of Stockton, California's Petition.

The second email, sent at 6:42 p.m., forwarded the following three pleadings filed under Docket Control No. OHS-3:

The third email, sent at 9:19 p.m., forwarded the following two pleadings filed under Docket Control No. OHS-4:

- 1. City of Stockton's Emergency Motion For Leave To Introduce Evidence Relating To Neutral Evaluation Process Under Government Code Section 53760.3(q);
- 2. Declaration of Marc A. Levinson In Support Of Emergency Motion For Leave To Introduce Evidence Relating To Neutral Evaluation Process Under Government Code Section 53760.3(q); and
- 3. Order Granting Emergency Motion For Leave To Introduce Evidence Relating To Neutral Evaluation Process Under Government Code Section 53760.3(q).

Each of the foregoing shows that the hearing thereon will be conducted at 10:00 a.m. on Friday, July 6th, in Department A, Courtroom 28, at the United States Courthouse in Sacramento. None mentions the judge who will conduct the hearings. That's because the City has not received any notice about which judge Chief Judge Kozinksi has appointed or will appoint to hear the Stockton case pursuant to Bankruptcy Code section 921(b). The July 6 hearing was scheduled based on my conversations with the Clerk of the Court, who spoke to one or more of the Eastern District Judges. On Monday, July 2, the City will file applications to shorten notice and proposed orders. Formal notice of the hearings will be sent to you once a judge has approved them. Naturally, if the judge declines to shorten time or schedules another time/date, the City will notify you immediately. Please note that under Local Rule 9014-1(f)(3), no written opposition is required for matters heard on shortened time.
