DECLARATION OF VIVIAN LOOK

CITY OF STOCKTON, *et al.*,

I, Vivian Look, declare:

I have personal knowledge of the facts set forth in this declaration and, if called as a witness, I could and would testify competently to these facts under oath.

I was born on April 1, 1951, and live at 912 Cold Brook Way, Galt, California.

I was hired by the City of Stockton in September of 2000 and retired in March of 2003 as an Administrative Assistant.

My spouse is my dependent on the City's Health Plan. We both have enough quarters to qualify for Medicare.

My PERS retirement check is \$700.83 My annual income is \$47,327.

I am informed and believe the City has adopted a monthly premium for retiree health benefits. If required to pay this premium to receive City Health Plan benefits, my premium would be \$1576.66 monthly or \$18,919.92 annually. That would represent approximately 40% of my income.

- My spouse and I are under continuing care for autoimmune disorders. I have chronic hepatitis and moderate glaucoma. I have been told by a pharmacist that the monthly cost of just the antiviral drug alone that I take for chronic hepatitis is \$800, which exceeds my entire monthly PERS retirement check of \$700.83.
- Due to the serious chronic conditions that we have, we have been told that neither of us would be insurable for individual policies in the private market in California. Loss of the City Plan would be catastrophic for us.
- I declare under penalty of perjury under the law of the United States of America that the foregoing is true and correct and that this declaration was executed in Galt, California, on JUNE 24, 2012.
